Synthetic turf field construction shall have consisted of laser graded, concrete anchor curbing, drainage and drainage stone and flat panel underdrain system. Track construction experience shall consist of construction of asphalt base, long/triple jump runways and pits, high jump, and concrete edge curbing. Bidders must provide verification of experience with this Form of Proposal and include a completed Bidders Qualification Statement with this proposal for the proposal to be considered.

All general contractors shall also be prequalified for general site construction by the Connecticut Department of Administrative services (DAS).
